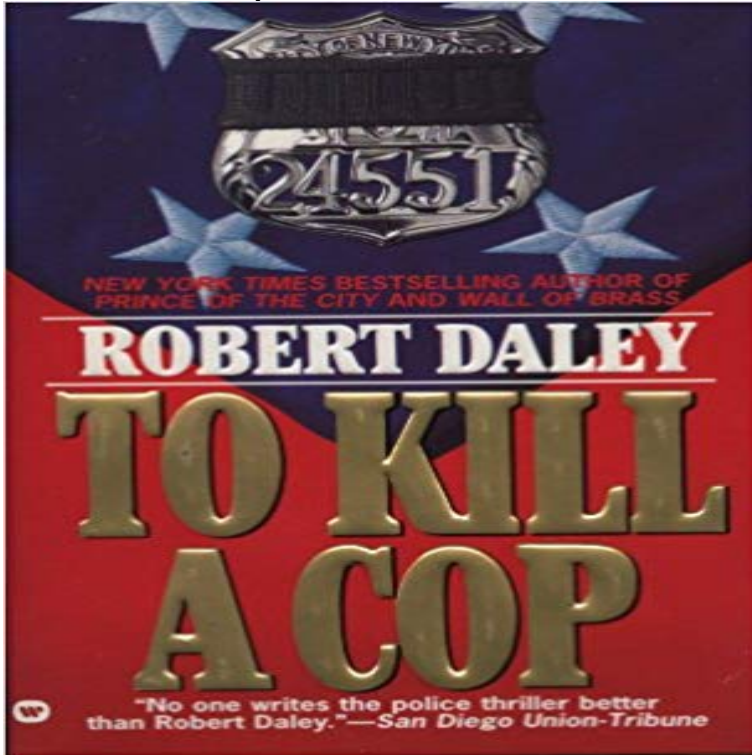


To Kill a Cop
